# *Taste of Scotland Festival*

## **Vendor/ Exhibitor Terms and Conditions**

1. **Set up & Breakdown:** All vendors must be set up and ready to sell by 9:00 am on the day of the festival. Vendors may begin setting up at 7:00am the day of the festival. Breakdown can start no earlier than 3:30 pm.
2. **Staffing:** vendor tables/booths must be manned at all times. Taste of Scotland is not responsible for merchandise, or display materials.
3. **Vendor Responsibility:** Vendor will be fully responsible for any loss or damage to his property by theft, fire or casualty. Taste of Scotland expressly disclaims any responsibility for the same. Each Vendor is responsible for the conduct of his/her employees and/ or representatives and activities must not detract from the image or welfare to the festival. Each vendor is responsible for selling their items and must bring their own cash.
4. **Vendor Spaces:** Vendor spaces will be assigned in the order that registrations have been received. Vendors must ensure that none of their display equipment extends beyond the space they have booked, including rails, stands, or additional equipment.
5. **Vendor(s) per Table:** There may be two vendors per space, but each one must register, note both sharing and pay a shared fee. Separate checks and applications must be received from BOTH vendors and a Check from each vendor with a notation that each vendor is sharing the same booth.
6. **Acceptance:** The Taste of Scotland reserves the right to decline any registration for space if it deems such action is in the best interest of the Festival on County property. Registration must be received one month prior to show. Each vendor must be the original producer of the items sold.
7. **Payment:** The full payment is a non- refundable registration fee for the booth space and show. This fee will be used to cover advertising and other incidental costs associated with the production of the festival. Taste of Scotland and Celtic Festival is a 501(C)3 entity.
8. **Electricity:** is available for vendor use.
9. **Table & Chairs:** *a table and 2 chairs are available upon request.* Each vendor is responsible to furnish his /her own table, chairs, and stands. A canopy will be needed for outside spaces and furnished by the vendor.
10. **Cancellation of Space:** Application fees are non- refundable. Taste of Scotland is not liable if weather or other conditions prevent the vendor from attending and fulfilling the contractual obligation as an vendor. NO refunds will be made for weather, accident, health, or other causes for non-participation.
11. **Alcohol:** NO ALCOHOL MAY BE SOLD OR CONSUMED ON THE SITE.
12. **Indemnification:** Vendor agrees to indemnify and hold harmless Taste of Scotland from and against any loss, expense, claims, damages, causes, of action, injuries, suits, or damages, suits to person or property, including attorney' fees, arising out of or related to the operation of the Vendors at the Festival.
13. **Terms & Conditions** Taste of Scotland reserves the right to make changes to these Terms and Conditions as necessary.
14. **Covid-19 Pandemic Requirements:** Hand sanitizer must be available at each vendor stall/space. Further requirement will be updated to follow State and County Health Department Guidelines as show date nears.
